Responsibilities of the Owner:

1. The owner is required to keep the launching trolleys in good working order. Any repairs to damage of cradles / trolleys shall be borne by the owner.
2. Trimaran owners must fold the hulls before recovery.
3. The owner shall use the space solely for the purpose of storing a boat and not for storage of any other personal property.
4. Owner working on his/her boats is responsible for the cleanliness of the area.
5. Owner is to ensure that his boat cover does not trap water as this would lead to mosquito breeding. The Owner is liable for any penalty charge by the National Environment Agency (NEA).
6. The owner shall not assign or permit any other person to occupy or use all or any part of the allocated space.
7. No sanding, grinding or scraping of boat at the car park.
8. Damaged trolleys, boat covers and other equipment are to be disposed off by the Owner.
9. The owner shall not assign or permit any other person to use his boat except his/her spouse, children or guests (not more than 6 times a year – refer to CSC Bye-Laws Clause 3). At its discretion, the Club will remove the boat if found the boat is used by non-members.

Terms & Conditions:

10. For keelboats less than 24 foot long and other larger multi-hull which require on land storage, launching and recovery service are only provided once a week subjected to weather / tide conditions:
 - a. Every Friday – Launching
 - b. Every Monday – Recovery
11. The Club reserves the rights to reject or postpone the launch and recovery date request at any time due to unfavourable tide or weather conditions.
12. The Club is not liable for any damage to the boat or trolley during launching or recovery service.
13. The Club is not responsible for missing equipment or damage to owner's property.
14. Changi Sailing Club reserves the rights to amend, change the contents or pricing without prior notice
15. The Club reserves the right to re-allocate the boat within the Club premises without notifying the owner.
16. The owner must ensure that every boat is displayed with a Dinghy Park sticker issued by the Club.
17. The allocation of space is on a first-come-first-served basis. A confirmation letter and agreement will be mailed to the owner when a space is allocated.
18. The Club reserves the right to require the removal of any boats kept in the boat park if storage fees are not paid promptly.
19. No Cars are permitted inside the fence.
20. Water Hoses - When you are done using the hoses, turn off the water and coil the hose next to its faucet.
