- (iii) No launching and recovery services will be available during regatta days, weekends and Public holidays.
- (iv) The Club reserves the right to reject or postpone launching or recovery date requests at any time due to unfavorable tide or weather conditions.
- (v) Boat owner is to indemnify the Club against any claim for loss or damage whilst his boat is being hauled up, launched or laid up.
- (vi) Owner must inform the Club in writing his appointed contractor and also the start and completion dates. Once the work is completed, the owner must inform the Club to arrange for launching. It is the responsibility of the owner to ensure that the boat is watertight and ready for launching.
- (vii) All boat slip application fees are non-refundable and non-transferable.
- (viii) Fully understand that there are risks involved with upslipping of boat operation and will not hold the Club, its employees and any contractors' involved, liable for any damage that may occur during the lifting and launching of the boat.
