- (a) Please note that signing up of membership does not guarantee a slot for your sail boat. You are required to contact the Club via email: enquiry@csc.org.sg to check on the availability of boat space. Mooring and storage fees apply.
- (b) **Only Ordinary member** is allowed to apply storage space for sailboat. The Office will contact you via email once your slot is confirmed.

1. **Mooring Application**

Mooring allocation is based on first come, first served basis and pending availability. The maximum boat length allows on water mooring is 50 feet.

2. Boat moored at the club is restricted to personal use, no charter or any form of loan to non-members is allowed.

3. The boat owner is required to continue paying for the mooring fee even if the boat is away for repairs or for other reasons.

4. **Acceptance of Mooring**

A confirmation letter and agreement will be sent to you once the mooring is available. If you accept the agreement, please sign and return it to us for processing. A deposit of amount equivalent to 3 month's of mooring fee is required.

5. **Change of Boat and or address details**

Any alterations to boat or personal details must be notified in writing to the Club as soon as possible to enable records to be maintained accurately.

6. **Transfer of ownership**

Please inform the Club by writing if you decide to sell your boat. If the boat is sold to a non-member, the boat must be removed as soon as possible.

7. **Ferry Service**

Ferry service is available at the following timing: **8.30am to 8.30pm daily**

8. The Club shall have the right to move any boat from its mooring should the need arise.

9. The Club shall not be liable for any loss or damage to the boat and equipment.

10. The Club reserves the right to amend or cancel the Rules and Regulations or any of them if the Club considers that such amendment or cancellation is necessary for proper safety, care or cleanliness of the Club.

11. The Owner shall operate, maintain and store the vessel and its equipment with due care and diligence. It shall be at the expense of the boat owner to keep and maintain the boat and its equipment.

12. All prices quoted are subjected to 8% GST.

13. All boat up slip application fees are non-refundable and non-transferable.

14. The applicant shall:

- (a) not deposit rubbish into the sea;
- (b) reimburse any costs incurred by the Club in taking action to secure the safety of the boat
- (c) not advertise any commercial or other venture on the boat without the Club's consent
- (d) indemnify the Club against all claims proceedings actions and damages whatsoever arising out of use of the said mooring.
